Applying for a Private Detective License

Step One - Fingerprint Cards

Applicants must make an appointment with MONROE COUNTY CENTRAL BOOKING (MCCB) to submit fingerprints. Call 570-992-6643 to make that appointment. A money order in the amount of \$25.00 payable to the MONROE COUNTY TREASURER must be brought to the fingerprint appointment along with two forms of identification. MCCB will take the prints on the applicant print card and supply the applicant with two copies of the print card: one to be attached to the PETITION and a second to be attached to the BACKGROUND INFORMATION SHEET (see Step Three).

Step Two - File a petition with the Clerk of Courts

The PETITION must include:

- 1. Name and address,
- 2. Date of birth and age,
- 3. Present and previous employment,
- 4. Citizen of the U.S.,
- 5. Address of principle place of business,
- 6. Minimum of three (3) character references (with addresses and phone numbers),
- 7. Minimum of two (2) acknowledgement certificates that applicant has been:
 - a. Regularly employed as a detective, or
 - b. A member of U.S. government investigative service(s), or
 - c. A sheriff, or
 - d. A member of the Pennsylvania State Police, or
 - e. A member of a police department with a rank or grade higher than a patrol officer for a period of at least three (3) years,
- 8. Two (2) passport size photographs,
- 9. Fingerprint card,
- 10. Affidavit of Publication (see Step four),
- 11. Affidavit of Service of Petition to the District Attorney,
- 12. A money order in the amount of \$15.00 payable to the Monroe County Clerk of Courts.

Step Three - Background Application

Applicants must fill out the attached BACKGROUND INFORMATION SHEET and then call the MONROE COUNTY DETECTIVE CENTER (570-517-3052) to schedule an **interview appointment**. The applicant must bring to the appointment the completed BACKGROUND INFORMATION SHEET, *two* forms of identification and a money order in the amount of \$17.50 payable to the PENNSYLVANIA STATE POLICE.

Step Four - Publication

A hearing date with be set approximately one month after submission of the applicant Petition. Prior to the hearing date the applicant is to publish a copy of the Petition and file an affidavit attesting to the publication. The publication will consist of the following: a) publication in the Pocono Record newspaper and the Monroe Legal Reporter, once a week for two consecutive weeks, with the last advertisement to appear not less than three (3) days prior to the scheduled hearing. Applicant must file an Affidavit of Publication, attaching proof of advertising.

The District Attorney will review the PETITION and complete a background investigation report which will be submitted to the Clerk of Courts.

Step Five - Hearing

A hearing date with be set four to six weeks after submission of the applicant **PETITION**. After the hearing, if the PETITION is granted, the applicant must complete the following:

- 1. file an original bond in the amount of \$10,000.00
- 2. Submit a money order payable to the MONROE COUNTY CLERK OF COURTS in the amount of \$200.00 for an individual, or \$300.00 for a partnership, association or corporation,
- 3. Submit a money order in the amount of \$47.50 payable to the MONROE COUNTY CLERK OF COURTS for the cost of the issued private detective badge.

A license, photo identification card and private detective badge will be issued by the Clerk of Courts.

The license will be issued for a period of two (2) years.
