### AFFIDAVIT OF PROBABLE CAUSE

#### Case Summary

On Saturday, May 4, 2024, at about 7:28 p.m., the West Caln Township Police and Westwood Fire Company Ambulance responded to a 911 call for an unconscious 12-year-old female, currently in the back seat of a pick-up truck located at 260 Reid Road. The 911 caller was Rendell Hoagland, the father of the minor child born on 7-04-2011 (hereafter "MH"). Hoagland reported to 911 that MH struck a tree while riding her bicycle at about 12:30 a.m. on May 4, 2024. Medical staff at Paoli reported numerous injuries and conditions highly specific to abuse on MH. MH died at the hospital on 05/04/2024. Evidence recovered in this investigation determined that Blink Cameras were installed in the residence and used to monitor MH. Recovered videos starting on January 1, 2024, through May 2, 2024, depict abuse of MH by Cindy Warren and Rendell Hoagland.

#### Affiant Introduction

Affiant Bernard Sean Martin, is a sworn police detective employed by the Chester County District Attorney's Office and has been so since Jan 9, 2017. Your affiant is empowered to conduct criminal investigations and make arrests for violations enumerated in the Pennsylvania Crimes Code (Title 18, Pennsylvania Consolidated Statutes as amended). Your affiant has been employed as a police officer since 2006. Prior to employment with the Chester County Detectives, your affiant was a Corporal employed by the East Pikeland Police Department, where your affiant was a field training officer, Municipal Drug Task Force lead officer, and investigative officer. In addition, your affiant was responsible for supervising all investigative activities for the department.

Your affiant has attended training courses on initial responses to police incidents, contemporary forensics, investigatory use of digital devices, use of force in law enforcement, interview and interrogation, and statement analysis. In addition, your affiant has received specialized training in interviewing, forensic evidence collection, principles of criminal investigation, theories of criminal behavior, and training on the Pennsylvania Rules of Criminal Procedure conducted by the Delaware County Municipal Police Academy, West Chester University, the Chester County District Attorney's Office, Pennsylvania State Police, and Federal Bureau of Investigation. Your affiant holds both a B.A. and M.S. in Criminal Justice from West Chester University. Your affiant also holds a Ph.D. in Leadership from Alvernia University.

During his career, your affiant has conducted and participated in a wide range of criminal investigations, including homicide, robbery, burglary, drug trafficking, sex crimes, assaults, child abuse, and financial crimes. Your Affiant has authored arrest warrants, search warrants, and court orders related to these investigations during his career. Your affiant has participated in the investigation, arrest, and prosecution of over 200 defendants.

#### CASE FACTS AND EVIDENCE:

ambulance and appeared to be noticeably underweight for her age. Officer Moore contacted Detective Thomas Goggin of the Chester County Detectives and described MH as looking emaciated, and that she had a weak pulse and was barely alive. Based on this information, the Chester County Detectives responded to assist West Caln Township with a formal investigation.

Chester County Detective Gerald Davis and Detective Goggin interviewed Cindy Warren who is the stepmother of MH at 260 Reid Road. Warren said she is in a relationship with Rendell Hoagland and has a biological son who is 9 years old, hereafter (GG), who also lives with them at the Reid Road home. Warren said Hoagland, Warren, MH and GG travelled to Yogi Bear's Jellystone Camp Resort, located at 340 Blackburn Road, Quarryville, PA 17566, on Friday 5/03/2024, for a three-day camping trip. During the interview, Warren indicated that the campsite at Jellystone was rented for 3 weeks and the family travelled back and forth from the campground. Because of rain occurring on Saturday, May 4, 2024, they returned to their home in West Caln Township but left the camper and their belongings at the campground with plans to return on Sunday, May 5, 2024. Warren insisted MH got into the back seat of Hoagland's truck by herself before they left the park. Warren said MH was not talking during the trip home and Warren assumed MH was sleeping. Warren said she was the right front passenger and Rendell Hoagland was the driver, and GG was the driver side rear passenger.

When asked about MH's injuries, Warren said there was an incident when MH was using the water slide at Yogi Bear on Friday, May 3, 2024. MH slid to the bottom of the water slide but didn't move out of the way fast enough and was struck by a larger child who was also using the water slide. Warren reported that MH sustained a minor injury to her chin from that collision. Warren then described for Davis and Goggin an additional incident where she claimed that MH was slightly injured shortly after midnight on May 4, 2024. Warren said that she and Rendell Hoagland were at a fire pit near their camper at about 12:30 a.m. on Saturday, May 4, 2024, listening to music on her phone through a Pandora subscription. At about that time, MH was riding a mountain bike when Warren heard a crash and saw MH had fallen off her bike and it appeared MH struck a tree. Warren claimed that MH had several accidents with her mountain bike because she was not accustomed to using hand brakes. Warren said MH sustained a small lump to the left side of her forehead and a small laceration to the bridge of her nose. Rendell Hoagland provided a Ziplock bag with ice to MH who put it on her head and sat on a picnic table for about five minutes after the bike crash. Afterward, MH was playing cornhole and playing with the dog until about 3:00 a.m. on May 4, 2024. Warren stated that she and Hoagland went to sleep around 5:00 a.m. on May 4, 2024, and slept until around 2:00 p.m. on May 4, 2024. When Warren woke up, she reported that GG and MH were awake and that she made pancakes for breakfast and that MH ate pancakes.

Asked about MH's weight, Warren told detectives MH had been losing weight for about two and one-half months prior to the call to 911 on May 4, 2024. Warren said she started giving MH PediaSure shakes twice a day to help MH gain weight. Warren said she also provided MH One A Day kids vitamins. Warren showed containers of both items to Detective Davis and Detective Goggin. In examining the PediaSure can, Detective Goggin noted that the can appeared to nearly full. Warren reported that she and Rendell Hoagland had made an appointment for MH to see a doctor "in the Poconos" for the weight issue on May 16, 2024. Warren said the family moved to West Caln from the Poconos around 2022 and that MH had not seen a doctor since the move and had no local pediatrician for MH.

While at the home, Detective Davis and Detective Goggin asked to see the bedrooms of both children and observed that MH had a work station in her bedroom where Warren indicated she did her cyber-schooling on her laptop. Warren provided investigators a cell phone purportedly belonging to MH during the interview at the home. Warren also provided investigators consent to search her cell phone

During an initial review of Cindy Warren's phone on May 5, 2024, investigators noted that all text communication with Rendell Hoagland prior to 930 pm on May 4, 2024 had been deleted from the device while other text message communications on the device dated back much farther. Warren reported regularly communicating with Hoagland via text message during her statement to investigators. A video of MH on the porch of the residence was recovered, dated January 31, 2024, from the initial review of Warren's phone. In the video, MH has a hood covering her head and can be heard crying. MH states that she is scared and a voice, believed to be Hoagland, can be heard laughing and talking to MH through the doorbell surveillance camera while MH is outside, saying "right away, right away...it's always someone else's fault" as MH audibly cries. MH's hand is holding the hood in the video and appears to be bruised black and blue. This video clip appears to be taken from the doorbell camera installed on the front door of the property. Investigators noted a number of surveillance cameras while at the home, although Warren claimed the cameras do not record. An audio recording of MH was also noted on the device. This recording, in the form of a screen recording of a phone call, is dated March 18, 2024, and contains a phone call between MH and a contact stored in the phone as "Malinda's Mom." This recording lasts 12 minutes and, during the call, MH can be heard sounding tearful and frustrated while complaining that a package sent by the mother contained a \$20 book and did not contain gift cards or sufficient body care products.

A Ram pick up truck bearing registration YYW-5558 was parked at 260 Reid Road in front of a garage on the driveway. Warren told Goggin and Davis that Hoagland drove that truck within the last three weeks. Detective Davis noted there was another plastic type storage building on the property behind the garage.

Westwood Fire Company transported MH to Paoli Hospital as a trauma patient, as helicopter transport services to local children's hospitals were unavailable. At Paoli Hospital, Dr. Rittenhouse pronounced MH deceased at 2158 hours. Hospital staff noted MH to have: sluggish pupils, bruising and abrasions to her neck, laceration to forehead, bruising and abrasions to her chest, bruising and deformity to her right arm, bruising and deformity to her right leg, deformity to her left leg and bruising to both knees. MH weighed 22.7kg (50 lbs) upon admission to the hospital. Medical staff noted that the child was severely emaciated and had significant bruising to her body. In the Emergency Department, medical providers noted fluid in the child's abdomen and test results indicated liver damage so MH was immediately taken into emergency surgery in an attempt to repair any internal injury that may have caused her nonresponsive condition. MH was noted to have liver ascites (fluid) in the abdomen but no laceration to the liver. Trauma surgeons were unable to save MH and she died from her injuries. Medical staff told Detective Martin and Detective Shave that MH's physical condition alarmed them and that the child's physical appearance should "not occur in this country." A review of the records from the hospital admission indicate that MH had fractures to both wrists and both ankles, her L3 vertebrae, and right inferior pubic ramus. She was also noted to have bilateral chest contusions, a liver contusion, and to be suffering from multi-system trauma, with circulatory failure, respiratory failure, and cardiac failure. MH had a temperature of 83 degrees upon admission to Paoli Hospital.

The father of MH, Rendell Hoagland, traveled to Paoli Hospital in his personal vehicle. Detective Jonathan Shave and Detective Ben Martin interviewed Hoagland inside Paoli Hospital on May 4, 2024. Hoagland similarly claimed that MH's physical injuries occurred during an unobserved fall from her bike at the Jellystone campground at approximately 1230 am on May 4, 2024. Hoagland reported that MH sustained a cut on her nose from the fall and that he got her an ice pack, which she used for a few

minutes before resuming play. Hoagland reported that MH awoke at approximately 130 pm on May 4, 2024 and that he and Warren were already awake when MH awoke. He said she ate a pancake for breakfast before the family eventually left the campground for the drive home due to the rain. During his initial interview, Hoagland described discipline methods which included forcing MH to march in place or run in place, forcing her to stand in the corner, and placing a lock on the snack cabinet so that MH could not access snacks in the home, although Hoagland claimed that all regular food remained accessible.

After being advised of his daughter's death, Hoagland was asked to accompany detectives to the Willistown Police Department, the closest local police station to Paoli Hospital, to discuss her physical condition and injuries. Hoagland reiterated his story that the child's only physical injuries came from the fall off the bike and the incident at the pool. Hoagland was unable to provide any explanation for the child's emaciated state, again claiming that she ate meals and that he only locked the snack cabinet and did not restrict all food. Hoagland discussed an incident in the fall of 2023 where he discovered that MH had been "selling" food at school, which he noticed when he demanded to examine her locker at a parent-teacher conference. Hoagland reported that he was frustrated with the school for minimizing the incident and he and Warren pulled MH from the school, opting to homeschool her instead. A review of MH's attendance records indicates that she last attended North Brandywine Middle School on or about November 30, 2023, with unexcused or illegal absences for the entire month of December and through her withdrawal from the school district on January 3, 2024. Hoagland admitted that CYF was notified after the incident at school involving MH's locker but claimed that CYF contacted him by phone only and never came to the house. Hoagland reported that MH had been caught hoarding food in her bedroom as well. Hoagland said MH had a cell phone but had the phone taken away 2-3 weeks prior to her death by Warren but he was unsure of the reason. During the interview at Willistown PD, Hoagland showed Detectives a photo of MH from January 5, 2024. MH's physical appearance in the photo differed drastically from her physical appearance upon medics arrival on May 4, 2024. Hoagland reported he had no photos of MH after the January 5th photo. When asked about any interactions MH had outside the home since being pulled from North Brandywine Middle School for cyber school, Hoagland insisted that MH logged into "zooms" related to her classes and had friends and likely saw them at times, although he provided no specifics for these interactions. Hoagland reported in his interview that he communicated regularly with Warren about the children and any discipline of the children and that he communicated with Warren about MH on May 4, 2024 via his cell phone as well as on prior dates.

During a search of the Reid Road home on May 5, 2024 pursuant to search warrant, investigators recovered numerous electronic devices, including a laptop and tablets, inside a locked gun safe in the home. Investigators also noted "Blink" brand home security cameras in every room of the residence. These cameras did not contain any internal SD cards. Investigators noted that the bedroom of GG contained a large TV and video game system and that MH had no entertainment items of any type in her bedroom. Notebooks and writings of MH were recovered in her bedroom, including a list where MH noted that some of her favorite things include food and snacks. Additional cell phones were located in a dresser inside Warren and Hoagland's bedroom.

A search of the camper at the Jellystone campground was also conducted on May 5, 2024 pursuant to search warrant. Investigators seized a pair of pants with blood and recovered and seized a pair of girl's underwear, believed to belong to MH, from the trash. Two bikes were seized from the camper as well. Investigators noted that the camper appeared in generally good condition and seemed to have been cleaned prior to their departure.

## AFFIDAVIT OF PROBABLE CAUSE CONTINUATION

Through investigation, investigators learned that Warren has a prior conviction for Endangering the Welfare of a Child in Monroe County, related to the physical abuse of her three-year old son and the beating death of a 2-year old child in her care.

MH's Android style blue and black cellphone in a pink case was seized by Chester County Detective's from inside of 260 Reid Road and secured pending a search warrant to search the phone.

Rendell Hoagland's Apple Iphone was seized by Chester County Detective's on May 5, 2024 at approximately 5:00AM, pending a search warrant to search the phone.

Detective Steven Parkinson reviewed Rendell Hoagland's Facebook page and observed several photographs taken of MH. The pictures appear to be taken inside of 260 Reid Road around Christmas 2023. These photographs were posted to Rendell Hoagland's Facebook page on January 5, 2024. In the pictures MH appears to be wearing a sweatshirt identical to the sweatshirt she is wearing in the above-mentioned video created on January 31, 2024. Another photograph shows MH standing next to a new mountain bike. There are also several photographs of a trailer camper and campsite taken posted to Rendell's Facebook page on April 20, 2024. In the post of the trailer camper and campsite, Rendell identifies that the pictures were taken at the Yogi Bear's Jellystone Park Camp-Resort in Quarryville, PA with Cindy Warren.

During an interview with Rendell Hoagland, Detectives Martin and Shave observed stains consistent with blood on his green T-shirt. This item of clothing was seized from his person at the Willistown Township police Station on 04/05/2024 at approximately 05:00 AM and logged into evidence.

On 05/06/24,, a search warrant was executed on Rendell Hoagland's Ford F150. During this search, a handcuff key was recovered, and a pair of Crocs that appeared to have blood on them were also recovered from the vehicle.

On 05/06/2024, a search warrant was executed on the account holder, Cindy Warren's cellular phone. Numerous videos watermarked as having been produced through the Blink system at 260 Reid Street, Coatesville, PA 19320, were recovered, which depict the physical abuse of the victim. Specifically, investigators viewed numerous videos of the child which show the child chained to furniture and forced to do calisthenics. Videos produced through Blink at the residence recovered are dated as far back as 7/24/23. In the videos, the child is crying and being yelled at by both Cindy Warren and Rendell Hoagland while being told to perform physical tasks or accused of misbehavior, like moving hair out of her face instead of performing calisthenics. In the videos, Hoagland and Warren can be heard addressing MH through the surveillance cameras and Warren can be heard threatening to advise Hoagland of the child's behavior and that she will be punished upon his return.

A video dated 1/1/2024 was recovered and shows MH secured to an air Hockey table with a silver in color leg shackle.

In a Video dated 01/27/24, Cindy Williams can be overheard telling MH through the Blink Camera to "keep moving and don't look for breakfast or Lunch tomorrow cause you're not getting it. And you won't get dinner either 'cause I'm not getting up."

On 01/27/24, an additional video clip shows MH chained to an air hockey table while Cindy Williams enters the room and tells her to shut up, calling MH a fucking idiot. 12 video clips go from 1:59 AM on

A video on 02/04/2024 at 7:59 depicts MH doing squats while chained to the air hockey table and reading a book.

A video dated 02/06/24 at 02:57 PM shows MH secured to a dresser with a leg shackle and marching in place. A video that same date at 3:58 PM depicts MH shackled to the air hockey table while Cindy Warren yells at her through the Blink Camera. MH is holding her arms in the air. 10 video clips show MH holding this pose from 3:58 PM through 9:02 PM.

A video dated 02/07/24 at 3:04 AM shows MH shackled to the air hockey table, sleeping on the floor with no blankets or pillow. Another clip at 07:30 shows her still asleep on the floor, followed by a clip at 7:35 am, where MH is seated with her arms in the air, still shackled to the table. Additional videos on 02/07/24 show MH chained to the table while walking in place. At 05:53 PM, Cindy Warren can be overheard telling MH that she "looks a little tied up at the moment, and because of bitches like her, she has pains in her cooter hole and won't move". MH responds Please, I'm Sorry; I know I can't move, and I'm sorry. "

An additional video dated 02/08/24 at 11:40 Am shows MH wearing a reddish pink shirt with white lettering that reads "2022" with other lettering shackled to the dresser again and doing squats. By 3:46, MH was moved to the air hockey table, where the video captured her doing squats. Cindy Warren can be overheard on the camera telling MH to take a ten-minute break. MH responds, "OK, thank you."

A video on 02/11/24 shows MH chained to the air hockey table, kneeling while Cindy Warren tells her to jump up. If she does it again, She (Warren) will come in and kick her in the teeth. A video on 02/12/24 at 01:23 AM shows MH chained to the table, sleeping on the bare floor.

A video dated 02/12/24 at 12:00 PM shows MH chained to the bedroom Dresser while holding books above her head for several minutes. During this video, Cindy Warren is heard through the Blink system telling MH that her head is not supposed to be sideways, that she is supposed to have the books over her head, and that she is supposed to be sitting up straight.

Additional videos from this date from 1:19 PM show the child chained to the air hockey table and forced to walk in place while crying.

On 02/13/24, additional videos were found where MH was chained to the dresser doing online schoolwork while Rendell Hoagland was yelling at MH, calling her a jackass, and telling her to put her hands on her legs.

On 02/28/24 at 07:53 hours, a video shows MH chained to the Hockey table where Cindy Warren yells at MH.

A video dated 04/03/24 at 05:18 Hours shows MH chained to the hockey table while picking at her hands and eating the skin.

A video dated 04/25/24 shows MH chained to a desk while Cindy Warren yells at her to keep moving. Cindy tells MH to "have a nice life, Bye Bitch."

The last video captured on 05/02/24 at 08:44 hours shows MH chained to a desk while doing online school.

In total, there are over a hundred video clips showing MH chained to furniture in the residence and being berated by Cindy Warren and Rendell Hoagland.

In addition to the blink videos, Texts were recovered between Cindy Warren and Rendell Hoagland discussing MH.

A message from Warren to Hoagland on 05/2/24 included a still image of MH where she has snot coming out of her nose. An abrasion is visible on the side of MH's right eye.

Additional messages starting at 12:52 AM on 05/04/24 discuss MH's worsening condition. The messages indicate that Rendell was out shopping for smelling salts and mentioned calling an ambulance at 05:32 PM. Cindy told him to "run" her and not call an ambulance.

These messages were recovered after being deleted from Warren's cell phone.

### CONCLUSION

Your affiant knows, through training, experience and common sense, that children MH's age require care and supervision and that, generally speaking, a child of this age would attend school or interact with others on a regular basis and have the ability to perform certain functions on her own without parental supervision. Your affiant is aware that otherwise healthy and asymptomatic children rarely die suddenly without explanation or detection and that the cause, circumstances and manner of a child death often take months to determine. Based on MH's physical condition and the statements of both Warren and Hoagland, as well as the photo and video evidence recovered thus far, your affiant knows that the child lost significant weight over a period of months and that her physical condition could not have occurred over a period of hours or days. Further, your affiant knows from training, communication with medical professionals and common sense that the explanation provided for the child's condition and death are inconsistent with and do not explain the child's condition.

MH became non-responsive while in the custody of Warren and Hoagland, her guardians and those legally required to provide her with care, protection, and support. Warren and Hoagland secluded MH from mandatory reporters and others who may have offered assistance in order to physically abuse and torment the child and used her seclusion to facilitate their crimes on an ongoing basis over a period of several months. They acted in concert with the intention of terrorizing and abusing the child and continued their actions until the child's death on May 4, 2024 at Paoli Hospital.
